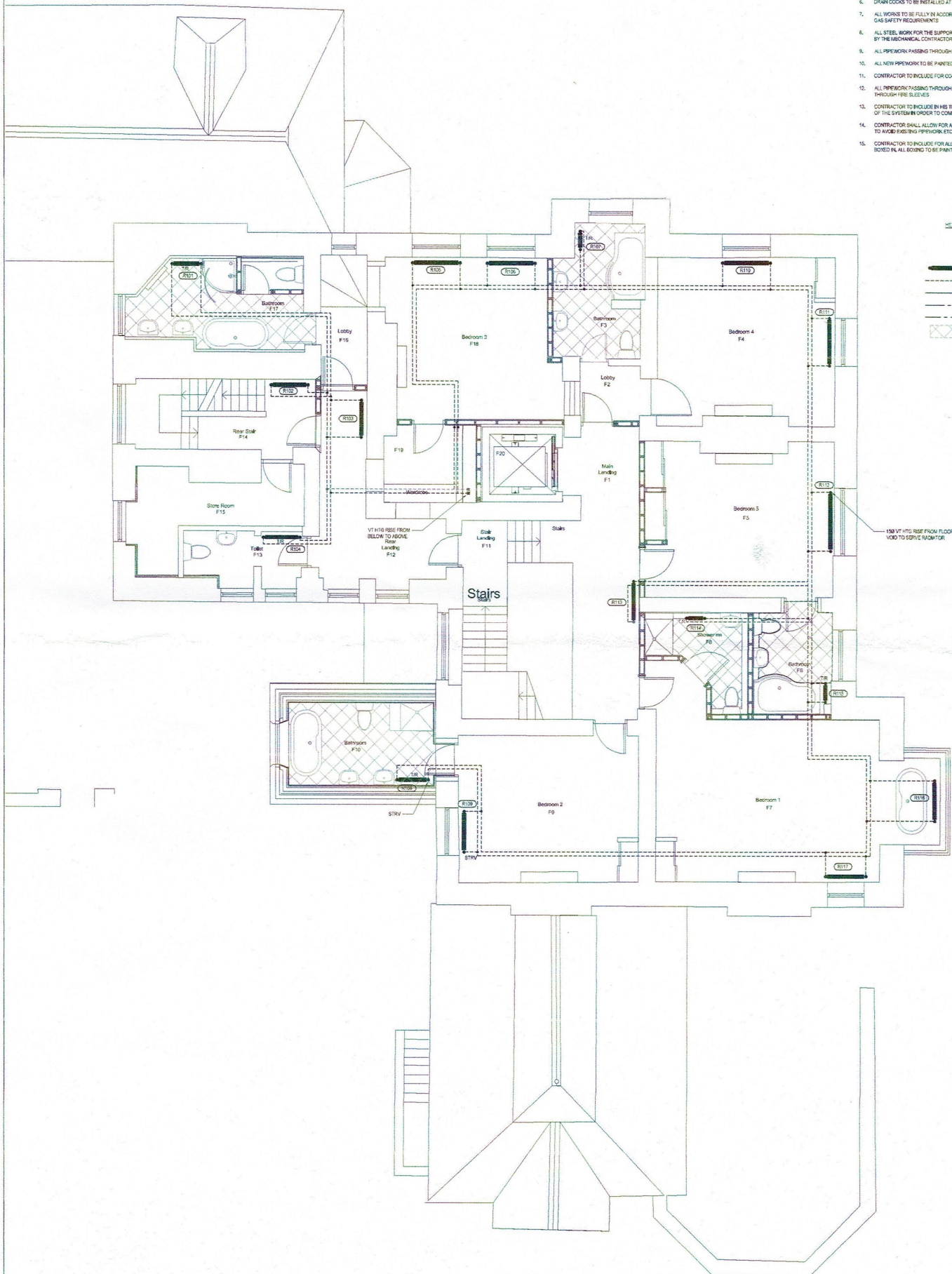

- ALLOW A DOUBLE PIPE SET WHEREVER PIPES PASS THROUGH WALLS, FLOORS AND CEILINGS TO ALLOW FOR POSSIBLE STRUCTURAL OBSTRUCTIONS
- DRAIN COCKS TO BE INSTALLED AT LOW POINTS AND AIR VENTS AT ALL HIGH POINTS
- ALL WORKS TO BE FULLY IN ACCORDANCE WITH LOCAL AND MODEL BYELAWS AND GAS SAFETY REQUIREMENTS
- ALL STEEL WORK FOR THE SUPPORT OF PLANT AND PIPEWORK SHALL BE PROVIDED BY THE MECHANICAL CONTRACTOR
- ALL PIPEWORK PASSING THROUGH WALLS AND FLOORS SHALL BE SLEEVED
- ALL NEW PIPEWORK TO BE PAINTED PRIOR TO INSTALLATION
- CONTRACTOR TO INCLUDE FOR CO-ORDINATING HIS WORK WITH ALL OTHER TRADES
- ALL PIPEWORK PASSING THROUGH FIRE BARRIERS AND BUILDS SHALL PASS THROUGH FIRE SLEEVES
- CONTRACTOR TO INCLUDE IN HIS TENDER FOR ALL DRAINING DOWN AND REFILLING OF THE SYSTEM IN ORDER TO COMPLETE THE WORKS
- CONTRACTOR SHALL ALLOW FOR ALL ADDITIONAL FITTINGS AND BENDS NECESSARY TO AVOID EXISTING PIPEWORK ETC
- CONTRACTOR TO INCLUDE FOR ALL EXPOSED PIPEWORK TO BE INSULATED AND SLOPED IN ALL BEING TO BE PAINTED OUT TO MATCH SURROUNDINGS
